Discipline Statement

North Lawndale College Preparatory High School students must behave in accordance with **Chicago Public Schools Uniform Discipline Code\***, **Code of Conduct**, **Water Policy** and **the individual high school** rules while on the trip. Students who violate rules are subject to disciplinary action in accordance with aforementioned policies.

**Code of Conduct**

At all times, students must be respectful of the tour chaperones, hotel and restaurant staff, and other students. Students must arrive on time for all departures and meetings. Students must attend and be alert at all sessions and/or events as prescribed on the tour itinerary or which may be designated by the tour chaperones. Students must dress appropriately while on the tour and will be responsible for personal property while on the tour. The activities and below are strictly prohibited:

- No drugs, smoking or alcohol usage or possession
- No destroying or damaging property
- No physical or verbal fighting or use of profanity
- No swimming
- No theft of other persons' property, hotel property, college campus property and property at visiting sites.
- No headphones, cell phone or text message usage during campus tour or presentations
- No hats indoors and no inappropriate clothing at any time
- No leaving the tour at any time without permission from chaperones

**Water Policy**

No student is permitted to enter a swimming pool, hot tub, lake, or other body of water, while on a school-sponsored trip. Under no circumstances are students allowed to use sailboats, rowboats, canoes or other recreational boats; this prohibition does not apply to student transport on U.S. Coast Guard approved commercial boat charters.
